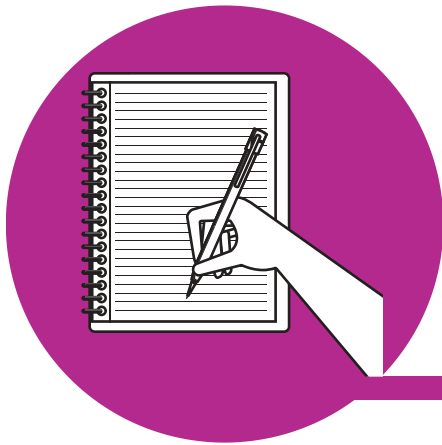

What is an argumentative essay and its types?

An **argumentative essay** is a type of writing that requires the author to research a topic. Through this research, they will collect, develop, and evaluate evidence and then form a clear opinion on the subject. Argumentative writing includes persuasive essays, research papers, analyses, and personal writing.

Argumentative essays try to get the reader to agree with one point of view. Essays like these should state the author's point of view and back it up with evidence. Since both sides of an argument are presented, the writer should focus on showing why their position is correct.

Argumentative research papers use a lot of outside sources to make their main point and back it up. When writing an **argumentative research paper**, it's crucial to be fair. Authors should present an equal number of sources for their main argument and the opposing point(s) of view.

Argumentative analysis essays look at other **argumentative essays** and break them down. It looks at the reasoning of another writer. Analysis essays need proof, clarity, style, and the ability to persuade. Since this type of **argumentative essay** analyzes another **argumentative essay**, the author has to make a case for the quality and persuasiveness of the original essay.

A **personal persuasive essay** does not need research. This kind of essay is based on opinion and personal taste, so the writer must use subjective reasoning. This **argumentative essay** style must persuade others to agree with a personal opinion. In a **personal argumentative essay**, research might help strengthen the main point. All sides of the issue should be examined to confirm the author's position and show the reader that it's well-developed.
