BACKGROUND	
2. The Producer wishes t	to make a feature film, provisionally entitled '' (Film). to obtain, and the Crew Member wishes to provide, the services re A (Services), on the terms set out in this agreement.

# **DEFINITIONS**

'Services', 'Engagement Period', 'Fee/Wages' and 'Credit' have the meanings given to them in Annexure A.

# THE PARTIES AGREE AS FOLLOWS:

### 1. Services

1.1 The Producer engages the Crew Member, and the Crew Member agrees to provide the services set out in Annexure A, for the period specified in Annexure A (**Engagement Period**), on the terms of this agreement.

#### 1.2 The Crew Member:

- (a) will provide the Services exclusively on and from the commencement of principal photography until the completion of principal photography, but otherwise will provide the Services non-exclusively;
- (b) will provide the Services skilfully and diligently, to a high artistic and technical standard and according to any specifications provided by the Producer.
- (c) If **Pick-Ups** are required upon completion of Principal Photography, the Producer and Crew Member shall negotiate a schedule for any additional day(s), however Producer is under no obligation to use the Crew Member for any such additional days. Payment will be made at the rate specified in Annexure B.

### 2. Fees

- 2.1 The Producer agrees to pay Crew Member and Crew Member agrees to accept as full compensation for all services and all rights granted hereunder, the sum of \_\_\_\_ per day.
- 2.2 The Producer must give the Crew Member an IMDB Credit for the aforementioned role within 30 calendar days of the film's completion.
- 2.3 The Producer must provide the Crew Member with a viewable HD link of the film within 90 calendar days of the film's official premiere, provided the Crew Member first signs a non-disclosure agreement.

## 3. Method of Payment

The Crew Member shall invoice the Producer at the end of the Principal Photography period with nominated bank account details included. Upon receipt of invoice, Producer shall pay the Cast Member within 14 days.

# 4. Relationship of the Parties

Both parties acknowledge that the Crew Member is not an employee of the Producer, and that the Producer is not responsible for complying with any obligations that would arise if the relationship were one of employer and employee. Further, nothing in this agreement gives rise to or may be construed as giving rise to a partnership between the Producer and the Crew Member.

## 5. Copyright Ownership and Use

The Producer is sole, exclusive and perpetual owner for use in any and all media, whether now known or subsequently devised of all rights, title and interest in and to the results and proceeds of the Crew Member's engagement and services, which for all purposes (including the copyright laws) shall be deemed a work-made-for-hire for the Producer (with the Producer being deemed the sole author of all such results and proceeds), as well as, the Crew Member's voice and likeness). The Producer shall have the right to use, refrain from using, change, modify, add to, subtract from the Services. The Crew Member acknowledges that s/he has no moral rights in the Production and consent to the proceeds of his/her services being used in the production.

The Crew Member's irrevocably grants the Producer, its successors and assigns, the rights to photograph and make films and sound recordings of the Crew Member's physical likeness and voice for 'behind-the-scenes' film and tapes without further compensation beyond the fees setout in Annexure A, in good faith and conscionable conduct between all parties. The Crew Member shall not engage in activities that might result in a conflict of interest.

The payment set out in this Agreement covers all services and rights of the Crew Member for the production.

The Crew Member releases the Producer, its employees, individuals assisting with the production, agents, assigns, and/or third parties associated with filming locations from all liability, from any and all claims, demands and proceedings (of any nature) arising out of Film and any use of the his/her performance (if any) and the Film unless caused by deliberate acts of misconduct or negligence by the Producer.

#### 6. Credits and use of name and likeness

- 6.1 The Producer must use its best efforts to ensure that the Crew Member is given a credit in the end credits of all copies of the Film as set out in Annexure A. However, no inadvertent failure to give the Crew Member this credit is a breach of this agreement.
- 6.2 The Crew Member authorises the Producer to use the Crew Member's name, likeness, voice and biography to obtain funding for the Film and, if the Producer produces the Film, to

produce, publicise and exploit the Film and any ancillary products, including in press kits, any "making of" programs and any DVDs.

## 7. Crew Member's representations and warranties

- 7.1 The Crew Member represents and warrants that:
  - (a) there are no restrictions that prevent the Crew Member from performing the Services and granting the rights granted under this agreement;
  - (b) nothing created, done or not done by the Crew Member in the course of providing the Services infringes the rights or interests, including without limitation the copyright, of any other person or organisation, is defamatory, or contravenes any other applicable law.
- 7.2 The Crew Member must unconditionally indemnify the Producer against, and must pay the Producer on demand the amount of, all losses, liabilities and expenses that the Producer incurs because any of the Crew Member's representations and warranties under this Clause are incorrect.

#### 8. Expenses

- 8.1 The Crew Member may only be reimbursed for an expense incurred in providing the Services if:
  - (a) the expense has first been authorised in writing by the Producer; and
  - (b) the Crew Member has produced evidence satisfactory to the Producer of the expenditure.

#### 9. Termination

- 9.1 This agreement may be terminated immediately by the Crew Member:
  - i) if the Producer has breached this agreement and has not remedied the breach within **14** calendar days after receiving written notice of such breach from the Crew Member; and
  - ii) upon such termination, the Producer shall pay Crew Member the full amount of the **wages** owing to the Crew Member under clause 2 for the Engagement Period up until the date of termination.
- 9.2 This agreement may be terminated immediately by the Producer:
  - i) if the Crew Member breaches the agreement and has not remedied the breach within **14 calendar days** after receiving written notice of such breach from the Producer (or 48 hours during principal photography);
  - ii) if the Crew Member breaches the agreement and the breach cannot be remedied;

- iii) if the Crew Member is or becomes physically or mentally incapable of performing their obligations under this agreement, or if the Producer and the Crew Member have creative differences to such an extent that the production schedule is, or in the Producer's reasonable opinion could be, delayed; or unable to proceed.
- 9.3 On the expiry or termination of this agreement,
  - (a) the Crew Member will deliver to the producer all notes, manuscripts, photographs, recordings and other materials produced by the Crew Member in connection with providing the services and in which copyright is owned by the Producer under the terms of this agreement; and
  - (b) the Producer remains entitled to the benefits of the Crew Member's Services and the rights granted to it by the Crew Member under this agreement.
  - (c) the following Clauses will survive termination of this Agreement, clauses 5 and 6.
- 9.4 A party may not make any claim or bring any proceeding against the other party as a result of the default or non-performance by the other party due to any natural disaster, strike, lockout or other industrial action, fire, war, act of government, political or civil disturbance.
- 9.5 The expiry or termination of this agreement does not affect any claim that either party may have against the other.
- 9.6 All rights granted and assigned pursuant to this Agreement shall be irrevocable under any and all circumstances and shall not be subject to reversion, rescission or termination. The Crew Member acknowledges that in the event of a breach of this Agreement by the Producer any application to enjoin or restrain the production, distribution, exhibition, advertising or exploitation of the Production or products based thereon or any rights therein or derived there from would be excessively disruptive and unreasonably damaging to the Production and the Producer's and third party's interests therein and consequently the Crew Member agrees not to apply for or support any such relief and accepts that the recovery of damages in an action at law will provide a full and appropriate remedy for any loss or damage incurred by the Crew Member as a result of any such breach.

#### 10. Assignment

The Producer may assign or novate the rights or obligations granted to them by the Crew Member under this agreement.

The Crew Member must not assign, novate or subcontract any of their rights or obligations under this agreement to any other person or organisation without the prior written approval of the Producer.

## 11. Notices

All notices required to be given under this agreement must be written, and may be delivered by electronic mail, hand, or sent by registered post to the address of the party set out at the top of this agreement.

Notices will be considered to have been served in the case of email when an electronic receipt is created or within two business days of having been sent in the case of hardcopy.

## 12. Disputes

- 12.1 If a dispute or disagreement (**Dispute**) arises between the parties in connection with this agreement:
  - one party must notify the other party in writing about the Dispute (Notice of Dispute); and
  - 2. neither party may start any litigation or arbitration in relation to the Dispute until the parties have complied with this clause.
- 12.2 The parties should meet within 14 calendar days after receipt of the Notice of Dispute and hold good faith discussions to attempt to resolve the Dispute.
- 12.3 The parties must continue to perform their respective obligations under this agreement despite the existence of a Dispute.
- 12.4 Nothing in this Clause 12 will impact either party's rights to terminate under Clause 9 of this agreement.

### 13. Confidentiality

The Crew Member agrees not to disclose any confidential information ("Confidential Information" which expression includes any and all information, photographs, locations, materials or documents whatsoever about this engagement, the affairs of Producer, the script for the Production, the Production and any members of the cast or crew of the Production) to any person without Producer's prior written approval in each instance. The Crew Member agrees not to take any unauthorised photographs or copy any Confidential Information in any form for any use whatsoever. The Crew Member agrees not to give interviews or authorise any publicity relating to the Production or any other Confidential Information without Producer's prior written approval. Uploading or distributing any images, including but not limited to mobile phone photographs, or information relating to the Production, crew, cast or locations onto the internet, including but not limited to social media such as Twitter, Facebook, Instagram etc, is strictly prohibited without the Producer's prior consent.

### 14. General

- 14.1 This agreement is the entire agreement between the parties about its subject matter. Any previous understanding, agreement, representation or warranty relating to this subject matter is replaced by this agreement and has no further effect.
- 14.2 The Crew Member acknowledges and agrees that damages are a sufficient remedy for any breach by the Producer of this agreement.
- 14.3 This agreement may only be changed in writing signed by all parties.
- 14.4 This agreement is governed by the law in force in Malta.
- 14.5 The Crew Member must comply with all policies and procedures of the Producer as notified to the Crew Member from time to time. Notwithstanding this obligation, the policies and procedures of the Producer are for the benefit of the Producer and are not incorporated into and do not form part of the Agreement.
- 14.6 This agreement supersedes all prior representations, arrangements, understandings and agreements between the parties relating to the subject matter of this agreement and sets forth the entire and exclusive agreement and understanding between the parties relating to the subject matter of this agreement.
